### Lawsuits – \$250K

small businesses that are "very-prepared" to achieve success in HR and compliance.

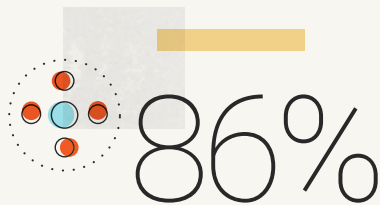
